Special attention is given to children's contest programs, education and training and ensuring their overall health and safety.

1. Purpose of the Safeguarding Plan

The purpose of this Safeguarding Plan is to ensure a safe and respectful environment for all participants of the FIG ART World Challenge Cup in Koper, with special attention to minors and vulnerable individuals. It outlines the preventive measures, reporting mechanisms, and responsibilities of all involved parties.

2. Scope of Application

3. Key Principles

- Zero tolerance for abuse, harassment, or discrimination.
- Child and athlete-centred approach.
- Clear reporting and support mechanisms.
- Confidentiality and respect for privacy.
- Proactive prevention and training.

Their role is to:

- Act as the first point of contact for any safeguarding concerns;
- Ensure incidents are handled respectfully and confidentially;
- Liaise with FIG Safeguarding Department as needed.

5. Prevention Measures

- **Accreditation control:** All accredited individuals will be vetted; access to athlete-only areas will be strictly monitored.
- Separate changing areas for male and female gymnasts; minors will be supervised.
- **Safeguarding training:** All LOC staff and volunteers will receive basic safeguarding awareness training before the event.
- **Code of conduct:** All delegations and personnel must sign and adhere to the FIG Code of Ethics and Safeguarding Policies.
- **Emergency contact points** will be available 24/7 during the event.

6. Reporting Concerns

Concerns may be reported:

- Directly to a Safeguarding Officer (in person or via phone/email)
- Anonymously (report boxes will be available at the venue)
- To FIG via the online reporting tool: <u>https://www.gymnasticsethicsfoundation.org/</u>

All reports will be:

- Taken seriously and investigated promptly
- Handled with confidentiality
- Reported to the FIG if they fall under FIG jurisdiction
- Escalated to local authorities if legally required

8. Accommodation & Transport

- All accommodations for minors will ensure appropriate adult supervision (respecting gender and privacy).
- Transport provided by LOC will be monitored by vetted personnel.

9. Media & Social Media Policy

- Athletes, especially minors, will be protected from intrusive photography or interviews.
- Media representatives must respect privacy zones and follow safeguarding rules.
- Use of athlete images will be in line with parental/guardian consent where applicable.
- Accordance with GDPR regulations, each participant of the World Chellenge Cup in Koper must provide consent for media usage. The participant has to agree to the following:
 - 1. I consent to being photographed and/or recorded during the World Chellenge Cup in Koper.
 - 2. I understand that the images and/or video recordings may be used exclusively for the purposes of the World Chellenge Cup in Koper organization and promotion.
 - 3. I acknowledge that such media may be shared publicly only in direct relation to the World Chellenge Cup in Koper (WEB PAGE: <u>www.gimnasticna-zveza.si</u>, <u>www.slogym.si</u>, FB: gimnasticna.zvezaslovenije, World Challenge Cup Art Slovenia, INSTAGTRAM: Gimnastična zveza Slovenije, Slogymwcup).
 - 4. I understand that the media will not be used for commercial purposes unrelated to the World Chellenge Cup in Koper nor shared with third parties not directly involved in the organization of the event.
